#### **Stakes Offered**

#### **AKC JC and QC TESTS**

The <u>JUNIOR COURSER TEST</u> is open to all whippets at least 1 year of age. A whippet running alone shall receive a certification from a judge on one date and a second certification from a different judge at a later date, stating that the whippet completed at least a 600 yard course with a minimum of four turns. The whippet must complete the course with enthusiasm and without interruption.

The **QUALIFIED COURSER TEST** is open to all whippets at least 1 year of age. A whippet (Qualifying Hound) running with another hound of the same breed - or another breed with a similar running style - (Testing Hound) shall receive certification from a licensed judge. The whippet must complete the course with enthusiasm and without interruption, sufficiently course the lure and not course the Testing Hound. The judge will certify that the Qualifying whippet ran cleanly and did not appear to present a hazard to the Testing Hound at any point in the qualifying course. This certificate is required to enter a whippet as an Open Stake.

The handler presenting the Qualifying whippet shall be responsible for providing the Testing Hound for the qualifying course. Upon successful completion of the Qualified Courser test, the judge completes a certificate and awards it to the handler.

This certificate must be submitted to the host club with the whippet's first entry in an Open Stake. The certificate must be included when the results of the trial are sent to the AKC.

#### **AKC TRIAL STAKES**

**<u>OPEN:</u>** Open to all whippets that have attained at least one of the following: AKC Qualified Courser Title, CKC Field Champion Title, ASFA Fch Title. Championship points may be awarded from this stake. Whippets who have earned an AKC Field Championship are not eligible to enter Open.

<u>OPEN VETERAN:</u> Open to all whippets, which are eligible to enter either Open or Special Stake, and are of Veteran age as determined by their Parent Breed Club. Championship or LCX points may be awarded from this stake.

**SPECIAL:** Open to all whippets that are eligible to enter the Open stake and have earned their AKC Field Championship titles. LCX points may be awarded from this stake.

**SINGLES:** Will be offered. Open to all whippets. Whippets with breed disqualifications are eligible to enter.

#### **Additional Stakes**

**Kennel Stake**: For two whippets, designated at the time of entry, entered in one of the regular stakes, owned and kenneled by the same person.

**Breeders Stake**: For two whippets, designated at the time of entry, entered in one of the regular stakes bred by the same individual.

**Note:** An Owner/Breeder may have more than one entry in the Kennel or Breeder Stakes as long as the two whippets comprising each entry are properly identified at the time of entry. A whippet may only be part of any one Kennel and one Breeder stake entry. Please send in Breeder/Kennel Stake forms indicating pairs along with properly marked entry forms.

High Scoring Dual Champion Stake: For the whippets that have both an AKC Conformation Championship and an AKC Field Championship title. An award will be awarded both Saturday and Sunday. Please send in High Scoring Dual Championship form along with fees.

Hounds under disqualification from AKC, ASFA, or CKC Field Trials may NOT be entered.


