Test/Trial Hours

Trial Hours: 7:30 AM until complete - **NO Day of Trial Entries**

There are no Whippet stakes at the event on Friday, Nov 27th. However, Whippets will be allowed to enter the JC/QC tests on this day. Whippets passing their QC tests at the 11/27/20 trial are not eligible to move up to the regular trial on that day but can do so on Sat (11/28) or Sun (11/29). Whippets looking to enter on 11/27/20 should look for the AWC Southern Regional Specialty AKC LC Trial Premium.

Trial Roll Call: 8:00 AM - ALL Hounds, early Roll for Field Committee, followed by draw.

If a hound passes the required QC Test and the owner/handler wishes to enter the subsequent trial, the AKC Coursing Director has granted this club permission to accept trial entries following the test. Entries in this case will be accepted for a period of 15 minutes immediately following the announced finish of the QC Test.

Conditions of Entry

- * Hounds must be one year of age or older on the day of the trial. All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified.
- * Hounds not present at the time of roll call will be scratched after a 5-minute grace period.
- * Bitches in season and lame hounds will be excused (with entry refunded).
- * All hounds will be examined at inspection for breed disqualifications.
- * Spayed or neutered hounds, without breed disqualifications, may be entered.

ONLY ON-LINE and complete entries WILL BE ACCEPTED.

First time open entries using ASFA or CKC Field Champion Waiver must Submit a Copy of the Championship Certificate with Entry.

Eligible Breeds and Registry

Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cinerco Dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Portuguese Podengo Pequeno, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis and Whippets (Sat and Sun only) that are one year of age or older, that have been registered with The American Kennel Club, or part of an AKC-registered litter, or otherwise, if whelped outside of the United States of America and owned by a resident of the USA, or of a country with a foreign registry organization whose pedigrees are acceptable for AKC registration and is registered with that registry, or that have been granted an Indefinite Listing Privilege (ILP) or Purebred Alternative Listing (PAL), are eligible to participate in lure coursing tests and trials and be awarded the prefix title of Field Champion and the suffix titles of Junior Courser, Qualified Courser, Senior Courser or Master Courser. Those sighthounds enrolled in AKC's FSS (Norrbottenspets, Peruvian Inca Orchid, Portugese Podengos (Medino and Grande) Thai Ridgebacks) which are eligible to compete in Conformation Miscellaneous class are eligible to compete in lure coursing tests and trials and will be awarded the suffix titles of Junior Courser, Qualified Courser, Senior Courser or Master Courser only.

Spayed or neutered hounds are eligible to participate. Monorchid and cryptorchid hounds are ineligible to participate. Hounds may not be entered as "registration or ILP pending". Breed disqualifications apply.

Portugese Podengos Pequenos and FSS breeds are not eligible to compete for Best in Field.

Any person, upon reasonable complaint, may be asked to leave the grounds of the field trial by the Field Committee and may be disciplined by the AKC. Children must be under control of their parent(s) or guardian(s) at all times.

Stakes Offered

AKC JC and QC TESTS – offered both days

The **JUNIOR COURSER TEST** is open to all hounds of an eligible breed at least 1 year of age. A hound running alone shall receive a certification from a judge on one date and a second certification from a different judge at a later date, stating that the hound completed at least a 600 yard course with a minimum of four turns. The hound must complete the course with enthusiasm and without interruption.

The **QUALIFIED COURSER TEST** is open to all hounds of an eligible breed at least 1 year of age. A hound (Qualifying Hound) running with another hound of the same breed - or another breed with a similar running style - (Testing Hound) shall receive certification from a licensed judge. The hound must complete the course with enthusiasm and without interruption, sufficiently course the lure and not course the Testing Hound. The judge will certify that the Qualifying Hound ran cleanly and did not appear to present a hazard to the Testing Hound at any point in the qualifying course. This certificate is required to enter a hound in an Open Stake.

The handler presenting the Qualifying Hound shall be responsible for providing the Testing Hound for the qualifying course. Upon successful completion of the Qualified Courser test, the judge completes a certificate and awards it to the handler.

This certificate must be submitted to the host club with the hound's first entry in an Open Stake. The certificate must be included when the results of the trial are sent to the AKC.

AKC REGULAR STAKES:

OPEN: Open to all whippets that have attained at least one of the following: AKC Qualified Courser Title, CKC Field Champion Title, ASFA FCh Title. Championship points may be awarded from this stake. Whippets who have earned an AKC Field Championship are not eligible to enter Open.

OPEN VETERAN: Open to all whippets, which are eligible to enter either Open or Special Stake, and are of Veteran age as determined by their Parent Breed Club. Championship or LCX points may be awarded from this stake.

SPECIAL: Open to all whippets that are eligible to enter the Open stake and have earned their AKC Field Championship titles. LCX points may be awarded from this stake.

SINGLES STAKE:

Singles: Will be offered. Open to all whippets. Whippets with breed disqualifications are eligible to enter.

Only pre-entries are accepted.

Hounds under disqualification from AKC, ASFA, or CKC Field Trials may NOT be entered.

BIF will be offered both days

First - Blue, Second - Red, Third - Yellow, Fourth - White, Fifth - Pink Best of Breed - Purple and Gold

Best in Field - Red, White and Blue

Junior Courser/Qualifying Courser – Green

How to enter your dog and earn AKC Titles

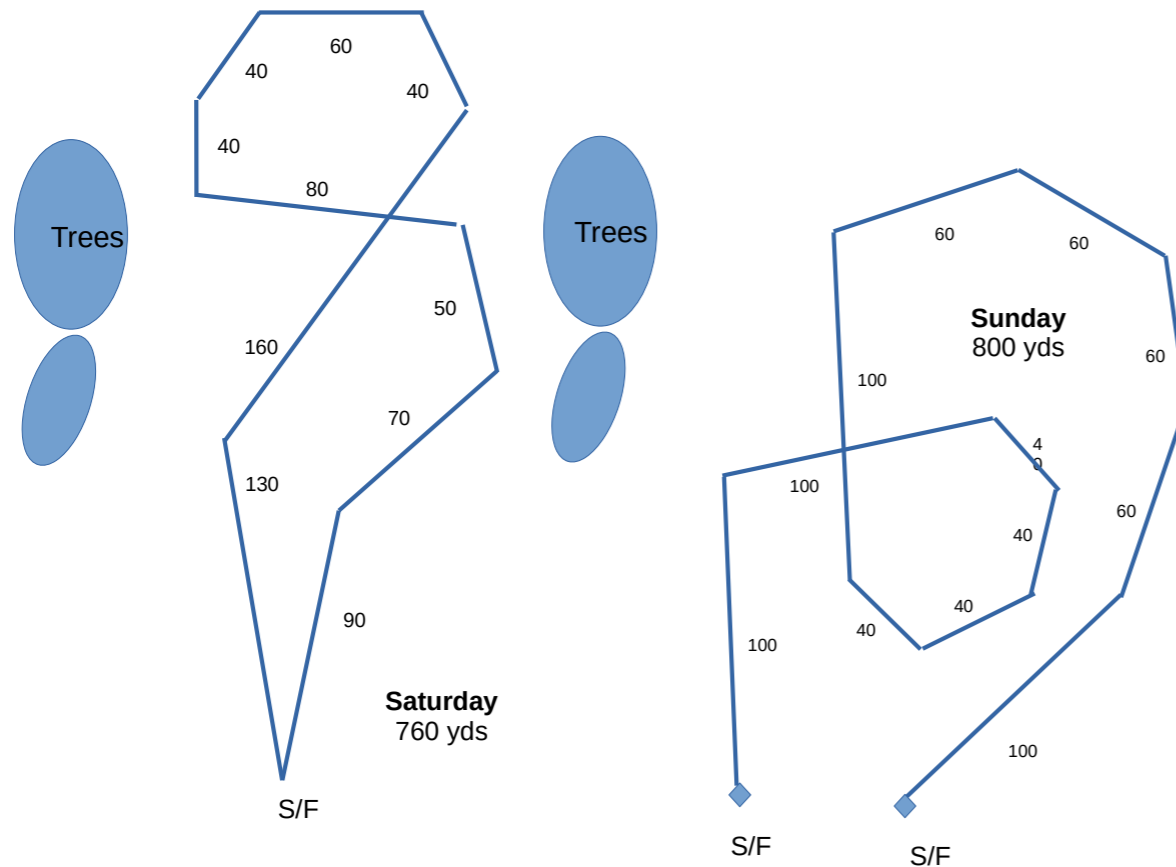
- * **FIRST** - you want to start with practicing your dog to make sure they will follow the lure and then move to practicing with other dogs (this is to make sure they are not interfering either aggressively OR playfully) - Practice is offered on Saturday after the trial is finished. Times may vary.
- * **NEXT** - if your dog has practiced successfully with other dogs (not interfering either aggressively OR playfully), you should enter him in the QC TEST. Your dog must first earn a **Qualifying Courser (QC)** certification before they can compete with other hounds.
- * To Enter the QC TEST sure to CHECK OFF “QC” ON THE ENTRY FORM and bring a filled copy of the “**Qualified Courser Certificate**” at the end of this Premium list. The Judge must sign this form and a copy of this certificate is required for their first time entry in the open stake.
- * **NEXT-** if your dog has earned a QC TITLE and you feel like they have practiced enough with other dogs, you can enter them in **Open Stake** and work towards the Senior Courser (SC) title. If your dog also wins a placement he will earn points towards his Field Championship title. (See Rule book for point schedule.)
- * To enter in the Open Stake: CHECK “OPEN” ON THE ENTRY FORM, **BRING A COPY OF THE QC CERTIFICATE AND PAY THE ENTRY FEE FOR OPEN.** There is no additional fee for the SC leg. To earn the SC title, the hound must run with at least one other hound, and must receive qualifying scores at FOUR (4) AKC trials under two different judges or judging panels.
- * When your dog has earned the SC title, he most likely will still be competing for Field Championship points. If he receives qualifying scores in 25 trials, he will earn the Master Courser (MC) title.
- * The title of **Field Champion (FC)** is a prefix to a hound's name. It is earned by obtaining 15 points from the Open or Veteran stakes. Dog must win 2 first placements worth 3 or more points under two different judges or judging panels (majors).
- * **FINALLY!** If your dog who has earned his Field Championship title must be entered in the **Special Stake.** **They are no longer eligible to enter the open stake. However they can continue on to work towards an LCX title!**

Field

The field has little shade and has natural and fence boundaries.

Please bring your own shade and water.

Battery powered, continuous loop lure machines will be used. The lure will consist of plastic strips. The members of the AWC reserve the right to alter the course plan as required by weather and/or field conditions on the day of the trial. The field will be reversed for the finals, runoffs, Best of Breed, Best In Field.



Neither Flintrock Farm, AWC, MAHA, nor its members will be responsible for any accidents at this trial.

PRACTICE

Will be held Friday and Saturday, if weather, equipment and daylight permit. Practice is \$3 per dog/run. Priority will be given to sighthound breeds.

Practice will NOT be offered on Sunday.

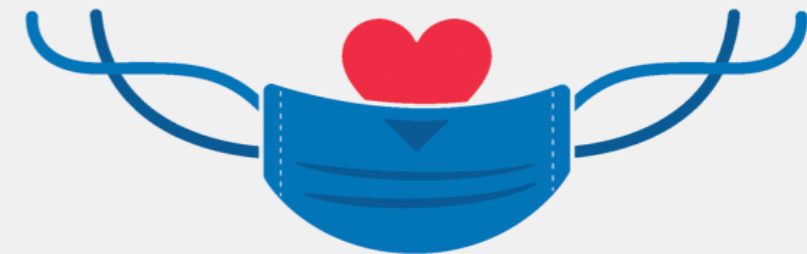

1. MAHA club members and all exhibitors will follow [State](#) and [local](#) guidelines.
2. All Field Committee and Lure Operators will wear facial coverings.
All participants will wear facial coverings. The club will not provide facial coverings.
3. No food will be served, bring your own breakfast, lunch and dinner. Please bring your own food, water and shade for yourself and your dogs.
4. We ask that you park at a safe distance away from each other.
5. Roll Call will be done at everyone's car, instead of a central location. The roll call committee will wear facial coverings. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
6. We will have some hand sanitizer or wet wipes in various locations for use. However we strongly encourage you to bring and use your own hand-sanitizer when possible.
7. We will prop open the porti-potties when not in use for more air flow.
8. Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
9. At the starting line, all exhibitors will stand 6 feet apart from one another.
10. Practice social distancing the best you can; especially around the FTS table, giving them space to work.
11. We ask that exhibitors approach the score sheets one person at a time and maintain social distance guidelines.
12. No self-serve ribbons anymore due to cross contamination.
13. **These trials will be pre-entry only. Payments by Pay-Pal ONLY!** If your dog QC's one of the days and you would like to enter them in the trials, let the FTS know and pay via PayPal. **Checks and cash will not be accepted day-of.**
14. **We will not be accepting any day-of entries or payments for entries, practice runs or anything. If any payments need to be made, a PayPal to awcsouthernregionLC@gmail.com will be accepted.**
15. Exhibitors who refuse to comply when reasonably asked to follow mask, sanitary or social distancing guidelines will be removed from the property.
16. The **areas around Annette's House and Barns are OFF LIMITS** without special permission. There will be no dinner on Saturday night.
17. All persons in attendance of these events MUST fill out a Waiver, attached....and submit it with their entries.
